Categories

1. **Black or White Drawing**...Rendered in any black and white medium or in any combination of black and white media...unless ink is solely used.
2. **Ink Drawing**...includes pen and ink, scratchboard or any one-color ink application. Colored paper is acceptable.
3. **Color Drawing**...rendered in any color media including color pencils, pastels and colored ink.
4. **Mixed Media**...any 2-dimensional entry that has a combination of two or more media that does not extend over 1/4 of an inch above the surface.
5. **Transparent Painting**...includes any media such as oil, acrylic, watercolor, marker pens and ink wash used in a transparent way.
6. **Opaque Painting**...includes media such as oil, acrylic, gouache or watercolor used in an opaque style.
7. **Relief Sculpture**...any media presented in relief that extends over 1/4 inch above the surface of the work.
8. **Sculpture**...3-dimensional work in any media.
